






### Background of Vihaan project

**India revamped care and support strategies in 2013 under NACP IV. Govt. has taken all treatment including OIs and care and support services is taken care by civil society organizations. India HIV/AIDS Alliance became Principle Recipient (PR) for care and support programme. Vihaan (Sanskrit word which means dawn's first light) care and support programme is implemented across India from 2013 onwards. The main goal of the programme is improving quality of life and survival of PLHIV. The programme being implemented with 21 Sub Recipient (SR) partners and 350 CSCs.**

**The operational guidelines was developed keeping care and support needs in focus and the guidelines developed in consultation with PLHIV community organization, subject experts from various streams and departments. NACO published this guidelines in December 2013. The programme has evolved over the years and certain changes had taken place in its approach and strategies when the programme based on policy changes and changing needs at field level. Moving forward to next phase (2022-2023) furthermore changes expected in view of the roll out of National policy of Test and Treat and also in the pipeline of implementing 'differentiated care model' towards accomplishment of 95:95:95 strategy and changing in funding pattern .Considering the changes in the strategy, approach and service delivery modes, certain changes proposed to care and support in care and support guidelines. Once these changes are accepted, same will be incorporated in guideline document.**

### **Vihaan objectives**

**Specific objectives of the programme include:**

- **Early linkages of PLHIV to Care, Support and Treatment services: The CSC will support PLHIV who have newly tested positive to enrol into the ART programme.**
- **Improved treatment adherence and education for PLHIV:Adherence education and support can help the PLHIV sustain and manage their treatment regimes. It is essential that all three elements of successful treatment are supported: the client, the provider, and the process.**
- **Expanded positive prevention activities: Improved positive prevention will contribute to the national efforts to prevent HIV transmission and**

reduce overall burden of disease.

- **Improved social protection and wellbeing of PLHIV: Social and economic well-being is an important component of care and support.** The CSC will facilitate access to the existing social welfare and protection schemes under different line departments, Corporate Sector, Public Sector Undertakings, Faith Based Organisations and civil society organization.
- **Strengthened community systems and reduced stigma and discrimination:** To ensure a robust system that supports the program goal and ensures stigma and discrimination free access to quality services, it is important that skills of the community members to advocate are strengthened. Establishing community systems like community advisory board (CAB) and discrimination response team (DRT) will bring in sustainable response.

## **Care and Support Centre (CSC)**

### **Changes in the Strategy:**

#### **Provision of Differentiated Care:**

Differentiated care is a client-centred approach that simplifies and adapts HIV services across the cascade to reflect the preferences and expectations of various groups of people living with HIV (PLHIV) while reducing unnecessary burdens on the health system. By providing differentiated care, also called differentiated service delivery, the health system can reallocate resources to those most in need.

Differentiated care aims to enhance the quality of the client experience. It puts the client at the centre of service delivery. It also ensures the health system functions in both a medically accountable and efficient manner. The central driver to adapting service provision is the client's needs. In line with WHO guidelines, clients are categorized in to 3 major categories based on their clinical characteristics, vulnerabilities, gender, age and socio-economic conditions which are explained below:

## Service package:

### Category 1

#### *High Priority Clients:*

- Clients who are yet to be put on ART
- Clients newly initiated on ART
- clients with less than 80% treatment adherence
- LFU/MIS cases
- Newly TB detected PLHIV cases
- Pregnant Women and children

### Category 2

#### *Moderate Clients :*

- Adolescents
- Discordant couples
- PLHIV from Key Populations

### Category 3


#### *Stable clients*

0Clients with more than 80% adherence


- No adverse drug reactions



## COVID-19

In Tiruvannamalai District from starting stage of Covid-19 curfew till now CSC PCO,PD and Outreach workers coming to office and also call to the Client. ORW's are shift basic / Rotation going to ART Centre. All workers give awareness to the client with Safety Precaution and also call to the client in order to take tablet through nearby Link ART Centre.

In ART they provide Mask and hand gloves to the workers. ART Medical officer asked workers call to the client safety measures. CSC Staffs asked client through phone call whether buy tablet or not. If client unable buy tablet means staff buy tablet from ART and give it to the home delivery.

Tiruvannamalai ART Centre does not provide client list to the CSC. Art centre willingly client they provide 22 client list. PD and Peer counsellor and ORW's give tablet to the home delivery .After that they provide 44 client list, for that also tablet gave to the staffs home delivery.

CSC Staffs call to nearby Link Art who the client buy tablet or not. If client not buy tablet then once again call to the client ensured to be csc staffs asked through whether buy **tablet or not**. If client unable buy tablet means staffs buy tablet

from Art and give it to the home delivery. Art does not provide line list to the csc.

So for 30 families provided the Rice and Nutrition support product through DAPCU. ART provide gloves and Mask and also insist field workers to wear it.

We are happy to give tablet to the Positive people during COVID-19 . In tiruvannamalai line list gave to csc they are willing give tablet to the client.
